Mr. Md. Abul Kalam Azad (Passport No.E00145564), Nazir of Khulna Metropolitan Sessions Judge Court entered India on 06/8/2024 AD) with 60 (sixty) days of outside Bangladesh leave (Earned leave on full Average salary) for advanced treatment. After Medical tests he has been diagnosed to have Hodgkin Lymphoma, a type of blood Cancer. Due to completion of chemotherapy, later he extended the same for another 75(seventy five) days. Treatment with chemotherapy is going on under the supervision of Dr. Naik Yamuna Pramod, MD, DM, Assistant Professor, Department of Haematology, Christian Medical College, Vellore, India. He needs to stay there for more 06(six) months for the sake of completion chemotherapy. For this reason, it was not possible to return to the country within the stipulated time. Hence for better treatment he again took 75 (seventy five) days outside Bangladesh leave (earned with full average salary) through Office order-74, Dated-01/12/2024 AD. Even though the said 75 (seventy five) days outside Bangladesh leave (earned with full average salary) has already near to be completed. Due to the serious physical conditions, he has prayed for extension of another 15 (fifteen) days leave outside Bangladesh (earned with full average pay) from 17/02/2025 AD to 03/3/2025 AD. As the reasons mentioned in his application for extension of leave are found to be satisfactory, from 17/02/2025 AD to 03/3/2025 AD outside Bangladesh leave (earned with full average pay) is hereby granted. Outside Bangladesh leave (earned with full average pay) for the period of 15(fifteen) days (from 17/02/2025 AD to 03/3/2025 AD) has been extended further. In his absence, Mr. Gonesh Kumar Das, Steno-Grapher Cum Computer will perform all duties assigned to him in addition to his duties. The Government will not spend any money in domestic or foreign currency on his foreign trip.
