Mr. Md. Abul Kalam Azad (Passport No.E00145564), Nazir of Khulna Metropolitan Sessions Judge Court after completion of chemotherapy under the supervision of Dr. Vikram Mathews, Professor, Department of Haematology, Christan Medical College, Vellore, India for Hodgkin Lymphoma, a type of blood Cancer, entered India on 14/9/2025 AD for the reviewing regular check-up. After checking up the medical report discloses the presence of some cancer cells. As per the advice of medical report and Doctors consultation he has already completed Radiotherapy under the supervision of Dr. Selvamani, Professor of the aforesaid Institution who advised him to review the same after 03(three) months. Due to regular checking up and collection of unavailable medicine in Bangladesh it is necessary to enter India again. For this reason, he needs to stay there for a period of 30(thirty) days. Accordingly, he has prayed for 30 (thirty) days leave outside Bangladesh (earned with full average pay) from 01/02/2026 AD to 02/3/2026 AD or for 30 (thirty) days from the date of his departure. As the reasons mentioned in his application for leave are found to be satisfactory, from 01/02/2026 AD to 02/3/2026 AD or for 30 (thirty) days from the date of departure outside Bangladesh leave (earned with full average pay) is hereby allowed without any objection. In his absence, Mr. Md. Hadiuzzaman, Administrative Officer in Charge, will perform all duties assigned to him in addition to his duties. The Government will not spend any money in domestic or foreign currency on his foreign trip.
